## Janesville – Beloit Kennel Club Barn Hunt Trial

**Trial Location: Rock County Fairgrounds**  
**1301 Craig Avenue, Janesville WI 53545** *(Do not mail entries to this address)*

Permission has been granted by the Barn Hunt Association, LLC to hold this trial under BHA Rules and Regulations.

**Open to all Breeds and Mixed Breeds of all sizes.**  
**Trials will be held inside non-heated building on hard-packed sand/fine-crushed gravel.**

#### Classes offered each day:

Instinct Test (Trial 1 only on each day), Novice, Open, Senior, Master, Crazy 8s (Crazy 8s limited to 25 runs per trial).  
Judging schedule will be determined after the trial has closed to facilitate the most efficient running order for the trials.  
Lunch breaks will be at the judges' discretion.

Day-to-day and trial-to-trial move ups/lateral moves available both days. Dogs earning a title may be moved up to the next class or laterally for the following trial. Move-ups/lateral moves will be accepted up until 10 minutes after the conclusion of the relevant class.

**Entry limit: 120 max runs PER DAY (combo of two trials) or 8 hours of judging, per judge.**

## EXHIBITOR INFORMATION

Dogs must be registered with Barn Hunt Association to participate.

Register your dog online at: [www.barnhunt.com](http://www.barnhunt.com). Allow at least 48 hours to receive a Barn Hunt number.

Offered classes: Instinct, Novice A/B, Open A/B, Senior A/B, Master A/B and Crazy 8s. Instinct and Novice A may be entered at the same trial, *until the dog has earned the RATN title. Dogs pre-entered in both Novice A and Instinct who finish the Novice title during this event can continue to show in Instinct for this event only, even if they choose to move up.* For all other regular classes, only one class per trial is allowed. **No entries will be taken over the phone or via email.**

## TRIAL SCHEDULE & INSTRUCTIONS

Saturday/Sunday

Gates open at 6:30am

Check in/Registration 6:45am – 7:45am

General briefing to begin at 8:00am, followed by individual class briefings at their assigned rings.

First dog in ring at 8:30am

The run order and further scheduling details will be emailed to all competitors after trial closes and the actual number of entries in each class are known. JBKC reserves the right to change run order based on entries.

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups.

**AWARDS:** Ribbons will be awarded for first through fourth place in Novice, Open, Senior and Master 'A' classes in each height division; and first through fourth place in 'B' classes for Novice, Open, Senior and Master, regardless of height. Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. High in Class award will be offered in Novice, Open, Senior and Master for 'A' and 'B' classes. Clean Race awards will be offered in Crazy 8s. ***Title ribbons will be awarded to all dogs earning a title, upon notification to trial secretary.***

**Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class/trial.** Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes for pre-entries on March 16, 2019, entry fees will not be refunded. *If bringing a bitch in season, please inform the Trial Committee prior to the trial, and you must inform all exhibitors at the judge's briefing.*

**REFUNDS:** Entry fees will be refunded if requested prior to early entry cut-off date of March 16, 2019. Entry fees will not be refunded in the event that the dog is absent, disqualified, excused or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, and an act of a public enemy or any other cause beyond the control of the organizing committee.

**WAIT LIST:** If trials fill, we will maintain a wait list. If an entry is withdrawn after the closing date and there are dogs on the waitlist who are able to take your spot, **ONLY** then will you receive a refund for your entry.

**DIRECTIONS TO TRIAL SITE:**

**I-90E/I-39S from the North:** Take Janesville Exit 175A. Keep right continuing westbound onto E. Racine St. into Janesville. Turn right at second traffic signal onto Randall Avenue. Travel 0.8 miles and turn left onto Craig Avenue, then right into entry gate. Follow signs to trial buildings.

**I-90W/I-39N from the South:** Take Janesville Exit 175. Keep left to take the ramp toward E. Racine St. (westbound). Follow through roundabouts, continuing westbound on E. Racine St. into Janesville. Turn right at second traffic signal onto Randall Avenue. Travel 0.8 miles and turn left onto Craig Avenue, then right into entry gate. Follow signs to trial buildings.

**PARKING:** Parking will be available in Fairgrounds by trial buildings. Parking is permitted inside the open-ended barns. We request that you please not park on the grass. A map of the fairgrounds will be emailed to all participants 10-14 days before the trial.

**COLLARS and LEASHES:** All dogs must be on a short leash and under control while on trial grounds. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs **MUST** run "naked," without a collar/harness. Collars/harnesses that can be easily and quickly removed and replaced are strongly encouraged. **NO flexi-leads allowed.**

Please bring adequate water for you and your dogs.

**SMOKING:** Smoking is not allowed on the grounds. If you must smoke, you will need to do so inside your vehicle and dispose of the butts in the vehicle also.

**LOUD/DISRUPTIVE DOGS:** Dogs that are loud and disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete.

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found by the judge and/or test committee.

Terrier sparring is not allowed on trial grounds.

Any dog that is sick, injured or lame will be excused from competition.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Rules can be found at <http://barnhunt.com>

It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In that case, no refund of any fees paid will be made.

**CRATING:** Indoor (heated building) crating space will be available. Be sure your crate is secure. **No x-pens allowed.**

**CLEAN UP AFTER YOUR DOG(S):** Dog exercise areas will be marked. A separate bitch-in-season area will be designated. Please pick up after your dog and dispose of waste in appropriate containers in the area. Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.
