Permission has been granted by the Barn Hunt Association, LLC to hold this trial under BHA Rules and Regulations.

Open to all Breeds and Mixed Breeds of all sizes.

Trials will be held inside climate controlled building on agility matting covered by a tarp.

Classes offered each day:

Instinct Test (Trial 1 only, each day), Novice, Open, Senior, Master, Crazy 8s (Crazy 8s limited to 25 runs per trial).

Lunch breaks will be at the judges' discretion.

Day-to-day and trial-to-trial move ups/lateral moves available both days. Dogs earning a title may be moved up to the next class or laterally for the following trial. Move-ups/lateral moves will be accepted up until 10 minutes after the conclusion of the relevant class.

Offered classes: Instinct, Novice A/B, Open A/B, Senior A/B, Master A/B (Champion) and Crazy 8s. Instinct and Novice A may be entered at the same trial, *until the dog has earned the RATN title. Dogs pre-entered in both Novice A and Instinct who finish the Novice title during this event can continue to show in Instinct for this event only, even if they choose to move up.* For all other regular classes, only one class per trial is allowed.

Dogs will be not run in any particular height order. Dogs being handled by the same person will be separated into different staged groups. There will be five dogs per blind for all classes.

AWARDS: Ribbons will be awarded for first through fourth place in Novice, Open, Senior and Master 'A' classes in each height division; and first through fourth place in 'B' classes for Novice, Open, Senior and Master, regardless of height. Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. High in Class award will be offered in Novice, Open, Senior and Master for 'A' and 'B' classes. Clean Race awards will be offered in Crazy 8s. ***Title ribbons will be awarded to all dogs earning a title, upon notification to trial secretary.***

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes for pre-entries on April 6, 2021, entry fees will not be refunded. *If bringing a bitch in season, please inform the Trial Committee prior to the trial, and you must inform all exhibitors at the judge's briefing.*

REFUNDS: Entry fees will be refunded if requested prior to early entry cut-off date of April 6, 2021. Entry fees will not be refunded in the event that the dog is absent, disqualified, excused or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, and an act of a public enemy or any other cause beyond the control of the organizing committee.

WAIT LIST: If trials fill, we will maintain a wait list. If an entry is withdrawn after the closing date and there are dogs on the waitlist who are able to take your spot, **ONLY** then will you receive a refund for your entry.

DIRECTIONS TO TRIAL SITE:

I-90E/I-39S from the North: Take WI-11 W exit, #177. Keep right to take the ramp toward Janesville. Turn right onto East State Road 11/WI-11. Turn right onto US Highway 51/US-51 N. Travel 0.59 miles. The JBKC building will be on the left.

I-90W/I-39N from the South: Take WI-11 W exit, #177. Keep left to take the ramp toward Janesville. Turn left onto East State Road 11/WI-11. Turn right onto US Highway 51/US-51 N. Travel 0.59 miles. The JBKC building will be on the left.

PARKING: Use the JBKC Training Facility parking lot. Additional parking is available in the grass lot adjacent to the north side of the building.

COLLARS and LEASHES: All dogs must be on a leash and under control while on trial grounds. Electronic collars, bark collars (including citronella), head halters or muzzles are not allowed. All other collar, lead and harness types are allowed. All allowed collars/restraints must be well fitted. **NO flexi-leads allowed inside the building**, but flexi-leads may be used outside while exercising a dog.

Please bring adequate water for you and your dogs.

SMOKING: Smoking is not allowed on the grounds. If you must smoke, you will need to do so inside your vehicle and dispose of the butts in the vehicle also.

LOUD/DISRUPTIVE DOGS: Dogs that are loud and disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete.

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found by the judge and/or test committee.

Terrier sparring is not allowed on trial grounds.

Any dog that is sick, injured or lame will be excused from competition.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Rules can be found at <http://barnhunt.com>

It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In that case, no refund of any fees paid will be made.

CRATING: **There will be no indoor crating at these trials.** Crating will be done out of your vehicle.

CLEAN UP AFTER YOUR DOG(S): Dog exercise areas will be available. A separate bitch-in-season area will be designated. Please pick up after your dog and dispose of waste in appropriate containers in the area. Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.
