Trial Location: JBKC Training Facility
2502 Center Avenue, Janesville WI 53546 *(Do not mail entries to this address)*

Permission has been granted by the Barn Hunt Association, LLC to hold this trial under BHA Rules and Regulations. Trials will be held inside climate controlled building on agility matting covered by a tarp. Barn Hunt Grounds includes the building, parking lot and grassy area on the north side of building. Limited indoor crating will be available on a first come, first serve basis.

Classes offered each day:

Instinct Test (Trial 1 only, each day), Novice, Open, Senior, Master, Crazy 8s (Crazy 8s limited to 20 runs per trial). (Run order will be published in the final trial confirmation.) Lunch breaks will be at the judges' discretion.

Day-to-day and trial-to-trial move ups/lateral moves available both days. Dogs earning a title may be moved up to the next class or laterally to the 'B' class for the following trial.

Any Judge of Record at this Event may be used in any ring. Qualifying scores will show the Judge who designed the Course. Judge of Record and Event Official dogs may be judged prior to Event start or as the first blind(s) of the Event. Judges are limited to 8 hours of judging and a maximum run value, which will require this club to limit entries accordingly.

Entries open on **June 27, 2022**. Entries close on Aug. 29, 2022

Entry fees

Postmarked on or before Aug. 29, 2022: \$15 Instinct; \$20 Novice & Open; \$22 Senior, Master & Crazy 8s

Postmarked after Aug. 30, 2022: \$20 Instinct; \$25 Novice & Open; \$27 Senior, Master & Crazy 8s

Late entries are not a guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.

There will be no Day of Show entries accepted at these trials.

If trials fill, we will maintain a wait list. If an entry is withdrawn after the closing date and there are dogs on the waitlist who are able to take your spot, ONLY then will you receive a refund for your entry.

All entries must be accompanied by entry fees and signed entry form to be valid. **No entries will be taken over the phone or via email.** A returned check does not constitute a valid entry. There is a \$35.00 fee for all returned checks.

EXHIBITOR INFORMATION

Dogs must be registered with Barn Hunt Association to participate. For a complete copy of the rules or to register a dog, go to: www.barnhunt.com.

Offered classes: Instinct, Novice A/B, Open A/B, Senior A/B, Master A/Champion and Crazy 8s. Instinct and Novice A may be entered at the same trial, *until the dog has earned the RATN title. Dogs pre-entered in both Novice A and Instinct who finish the Novice title during this event can continue to show in Instinct for this event only, even if they choose to move up.* For all other regular classes, only one class per trial is allowed.

TRIAL SCHEDULE & INSTRUCTIONS

Door opens at 7:00am each day.

Check in: Upon arrival. Handlers are encouraged to check in at least 20 minutes prior to the start of their class.

General Briefing: 8:15am

Judge's Briefing: Ringside, prior to Instinct and Novice classes.

Judging starts at 8:30am in both rings.

Dogs will not run in any particular height order.

Ring A will be running Senior T1, Master T1&T2 and Crazy 8s T2. The blind for Ring A is 10'x10'. There will be 4 dogs per blind for Ring A.

Ring B will be running Instinct T1, Novice T1&T2, Open T1&T2 and Senior T2. The blind for Ring B is 10'x15'. There will be 5 dogs per blind for Ring B.

AWARDS: Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. Ribbons will be awarded for first through fourth place in Novice, Open, Senior and Master 'A' classes in each height division; first through fourth place in Master 'B' in each height division; first through fourth place in 'B' classes for Novice, Open and Senior, regardless of height. High in Class award will be offered for 'A' and 'B' classes in Novice, Open, Senior and Master. Clean Race awards will be offered in Crazy 8s. ***Title ribbons will be awarded to all dogs earning a title, upon notification to trial secretary.***

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes for pre-entries on Aug. 29, 2022, entry fees will not be refunded. *If bringing a bitch in season, please inform the Trial Committee prior to the trial, and you must inform all exhibitors at the judge's briefing.*

REFUNDS: Entry fees will be refunded if requested prior to early entry cut-off date of Aug. 29, 2022. Entry fees will not be refunded in the event that the dog is absent, disqualified, excused or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, and an act of a public enemy or any other cause beyond the control of the organizing committee.

PARKING: Use the JBKC Training Facility parking lot. Additional parking is available in the grass lot adjacent to the north side of the building.

COLLARS and LEASHES: All dogs must be on a leash and under control while on trial grounds. Electronic collars, bark collars (including citronella), head halters, uncovered prongs or muzzles are not allowed. **NO flexi-leads allowed inside the building.** Flexi-leads may be used outside while exercising a dog.

SMOKING: Smoking is not allowed on the grounds. If you must smoke, you will need to do so inside your vehicle and dispose of the butts in the vehicle also.

LOUD/DISRUPTIVE DOGS: Dogs that are loud and disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete.

- Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found by the judge and/or test committee. Any dog that is sick, injured or lame will be excused from competition.
- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Rules can be found at: www.barnhunt.com
- It is expressly understood that exhibitors are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In that case, no refund of any fees paid will be made.

CLEAN UP AFTER YOUR DOG(S): Dogs may be exercised on any grassy area. A separate bitch-in-season area will be designated. Please pick up after your dog and dispose of waste in appropriate containers.
